Test purpose

Aims of the in-use test:

- assessment of long-term sensitive skin tolerance to the tested product;
- assessment and verification of the performance (properties) of the product declared by the Manufacturer;
- Consumer evaluation.

The aim of the instrumental test:

- assessment and verification of the performance (properties) of the product declared by the Manufacturer – the long-term effect.

Microbiological purity test

The product is microbiologically approved.

Microbiological purity tests were carried out in the GBA POLSKA Laboratory / ~~delivered by the Customer~~ *.

Dermatological test

The product is dermatologically approved.

Dermatological tests were carried out in the GBA POLSKA Laboratory / ~~delivered by the Customer~~ *.

Qualitative composition of the product

INCI ():** *Terminalia Ferdinandian (Kakadu) Fruit Extract, Aloe Barbadensis Leaf Juice, Glycerin, Chamomilla Recutita (Matricaria) Flower Extract, Acer pensylvanicum (Striped Maple) Leaf Extract, Acer Saccharum (Sugar Maple) Leaf Extract, Acer Rubrum (Red Maple) Leaf Extract, Psoralea Corylifolia (Babchi) Seed Oil, Citrus Aurantium Dulcis (Orange) Peel Oil, Xanthan Gum.*

(**) – The Customer is fully responsible for the compliance of the samples delivered for testing with the declared qualitative composition; the Laboratory does not analyze the composition of the sample for compliance with the current legal requirements.

The scope of the tests is in accordance with:

- Regulation of the European Parliament and Council Regulation (EC) No 1223/2009 of 30 November 2009 on cosmetics
- Regulation of the European Parliament and Council Regulation (EC) No 655/2013 of 10 July 2013 on cosmetics
- Cosmetics Europe - The Personal Care Association Guidelines „Product test Guidelines for the Assessment of Human Skin Compatibility 1997”
- Cosmetics Europe - The Personal Care Association „Guidelines for the Evaluation of the Efficacy of Cosmetic Products 2008”

Research methodology

In-use test was carried out:

- according to the internal procedure of the Cosmetics Research Centre, PB-34/LK;
- under the guidance of a specialist and a dermatologist;
- on a group of 20 study subjects with sensitive skin at home.

The tested sample was used in accordance with the Manufacturer's recommendations. After the declared time of application, the subjects were asked to fill in the evaluation questionnaire according to their own feelings. In the evaluation sheet, in the part containing the Manufacturer's declarations, a 4-point scale was used, with an equal number of positive and negative answers.

A declaration may be confirmed when the sum of positive answers exceeds 50% of the assessments of all subjects.

The test results may be influenced by factors such as: the type and condition of the face skin, lifestyle, genetic conditions, individual preferences, environmental conditions.

Instrumental tests were carried out:

- in the In VIVO Research Laboratory of GBA POLSKA;
- under the guidance of a specialist;
- on a group of 20 subjects;
- using specialized measuring equipment from Courage & Khazaka, i.e. :
 - Visioface ® 1000D – images showing the reduction in discolouration were taken in according to internal procedure PB – 65/LK;
 - Mexameter MX18 - measurement of melanin (pigmentation on the skin) according to the PB-42/LK internal procedure;
- on individually selected areas of the face skin, the same at the beginning of the tests (T_0) and at their end (T_1);
- on the thoroughly cleansed skin, without make-up or other cosmetics.

The declaration can be confirmed if the improvement is confirmed in the majority of subjects, i.e. 11 out of 20. An improvement can be declared if the change in value exceeds the measurement uncertainty.

Product effects / properties declared by the Manufacturer

The effects / properties of the product declared by the Manufacturer are included in the questions of the evaluation questionnaire.

Selection of the Study Subjects

The selection of the Study Subjects was conducted in accordance with the Research Procedure PB-34/LK, taking into account:

- the Declaration of Helsinki of 1964 (with subsequent amendments)
- Current Polish and European legal regulations
- Cosmetics Europe directives - The Personal Care Association with use of inclusion and exclusion criteria

20 volunteers with sensitive skin were selected for the in-use and instrumental tests. They completed a detailed questionnaire regarding their lifestyle, current health condition, past illnesses, eating habits, use of medicines and stimulants. All volunteers in the application study were selected for the instrumental study.

All volunteers selected for the study met the requirements for inclusion in the study and signed consent to consciously participate in it. They were also informed about the purpose of the study, method of testing and about possible side effects.

All participants of the long-term effect study (in-use and instrumental) were obliged to:

- report to the Cosmetic Research Centre on the dates specified in the test plan,
- use the product regularly during the period of 4 weeks,
- not to use any other products with identical or analogous properties during the tests,
- not to change, for the entire duration of the test, the face skin care products used so far, intended for purposes other than the tested product,
- immediately discontinue the use of the product and to report to the specialist and/or dermatologist supervising the research in case any undesirable effects occurred.

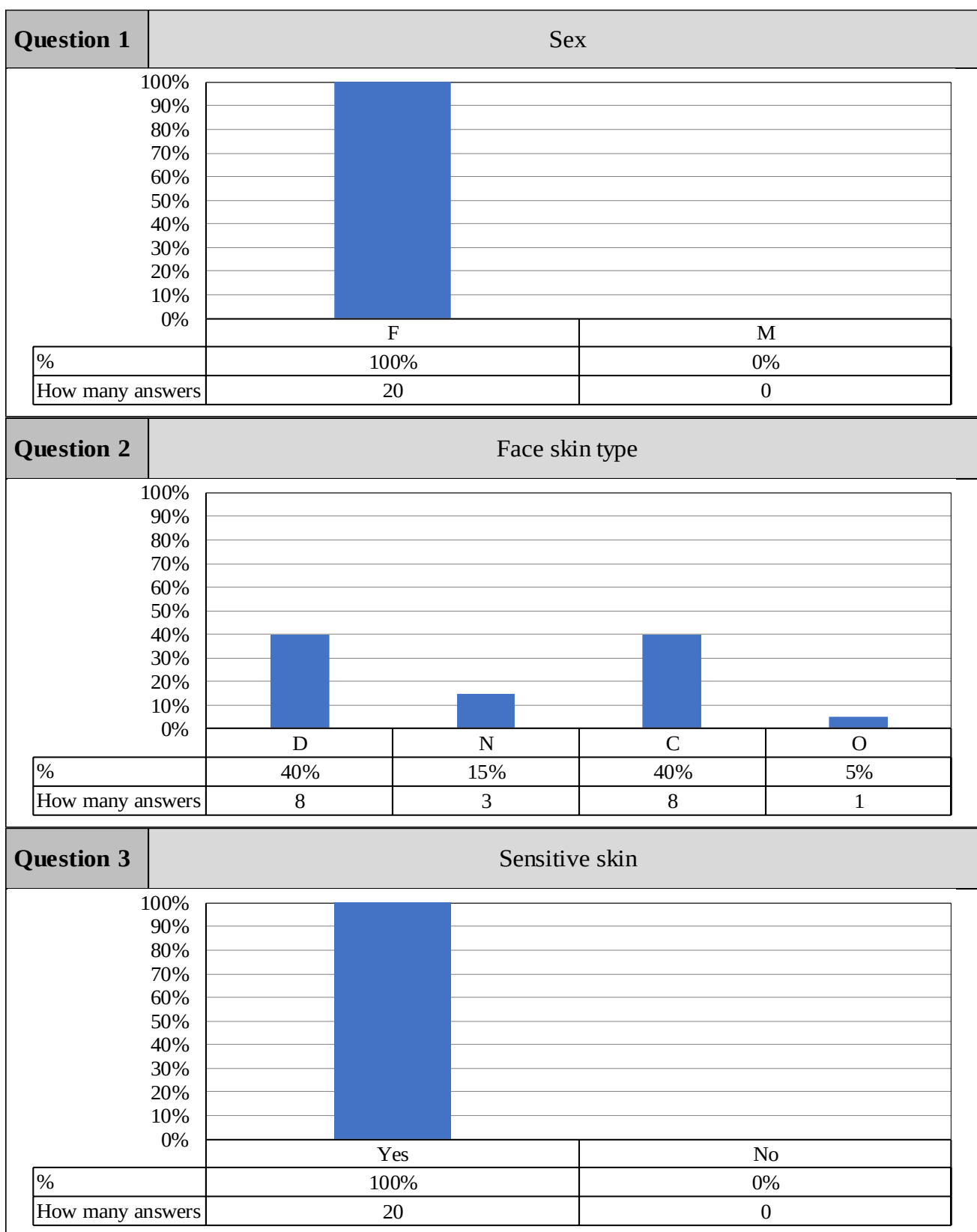
Characteristics and composition of the group participating in the study

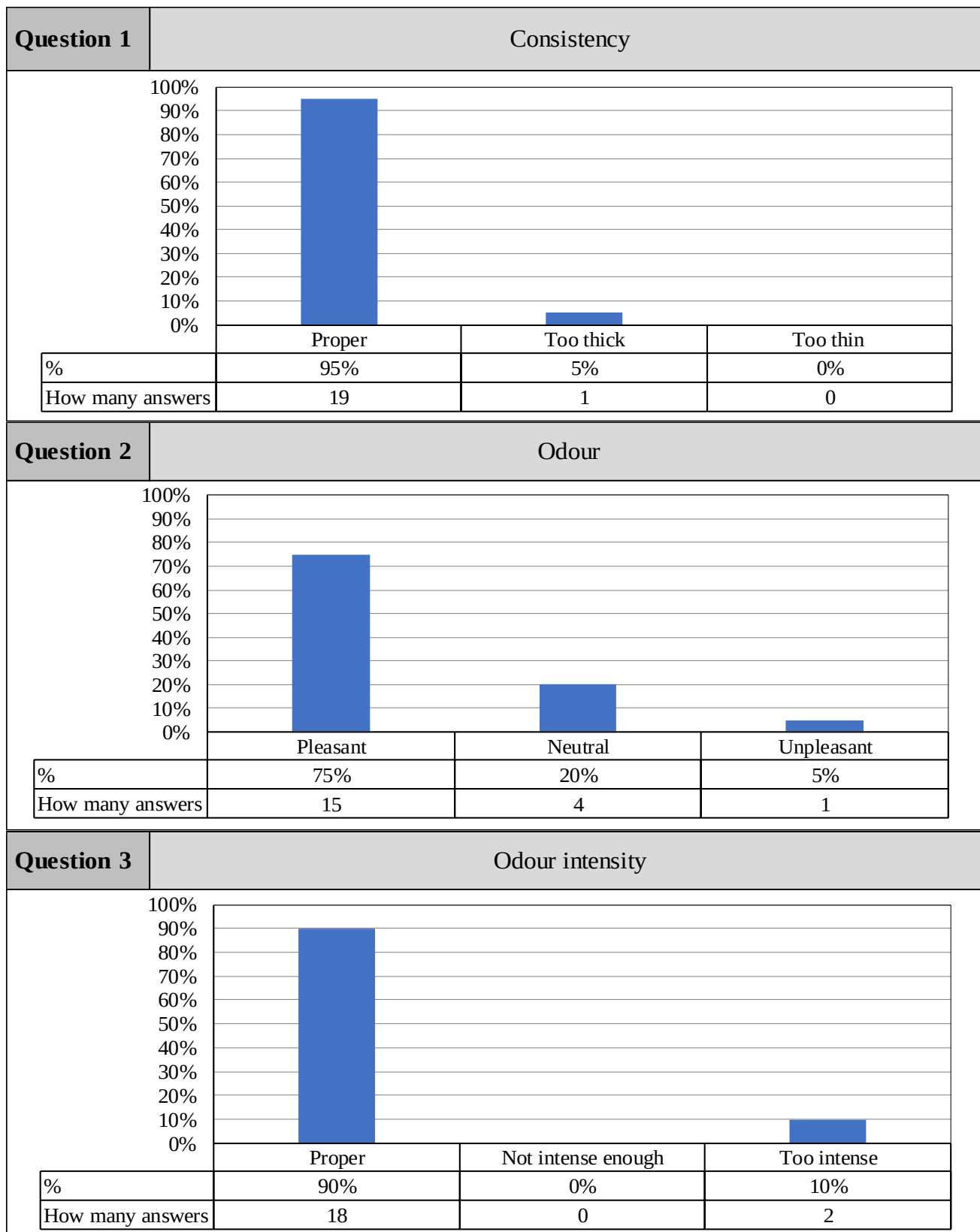

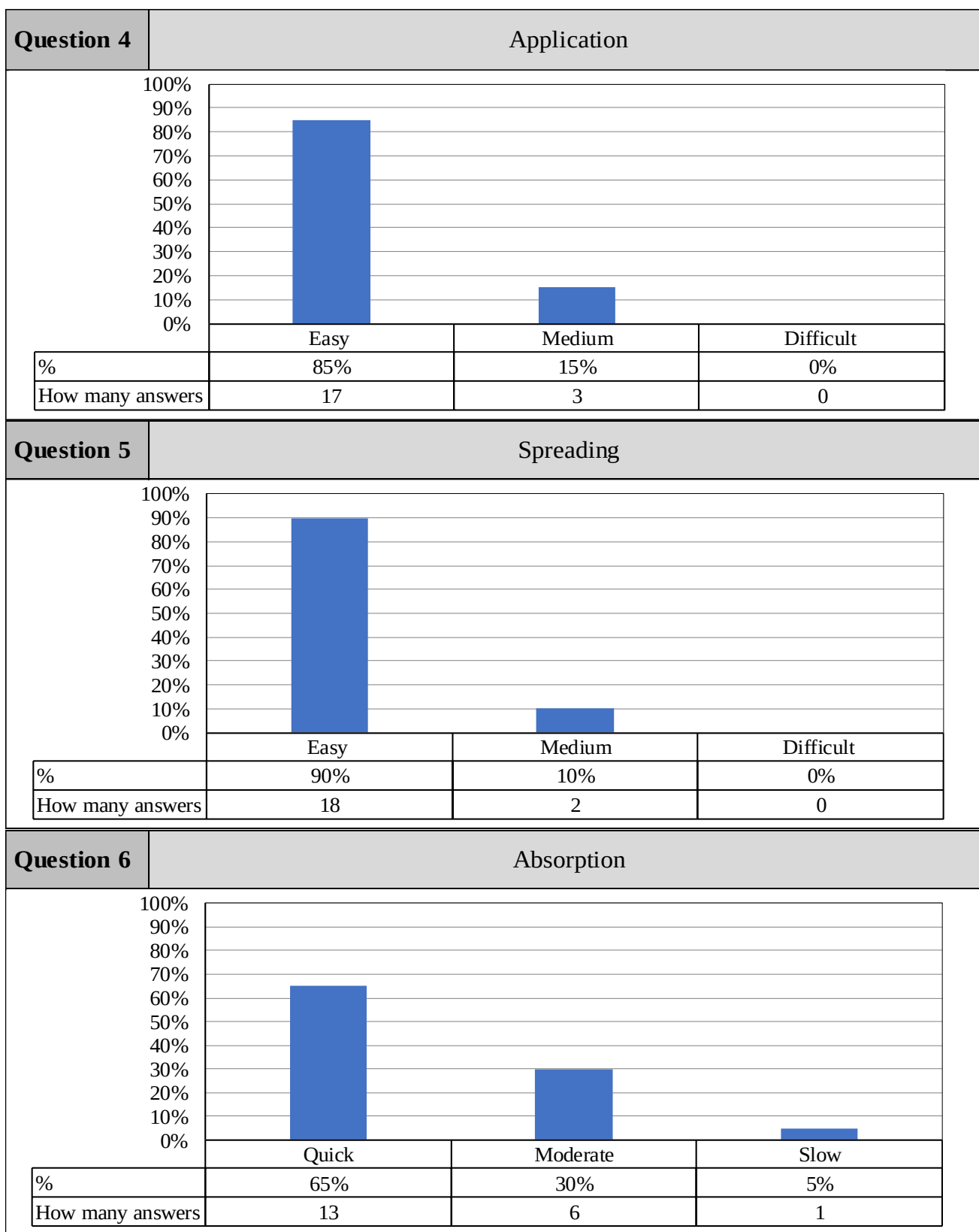

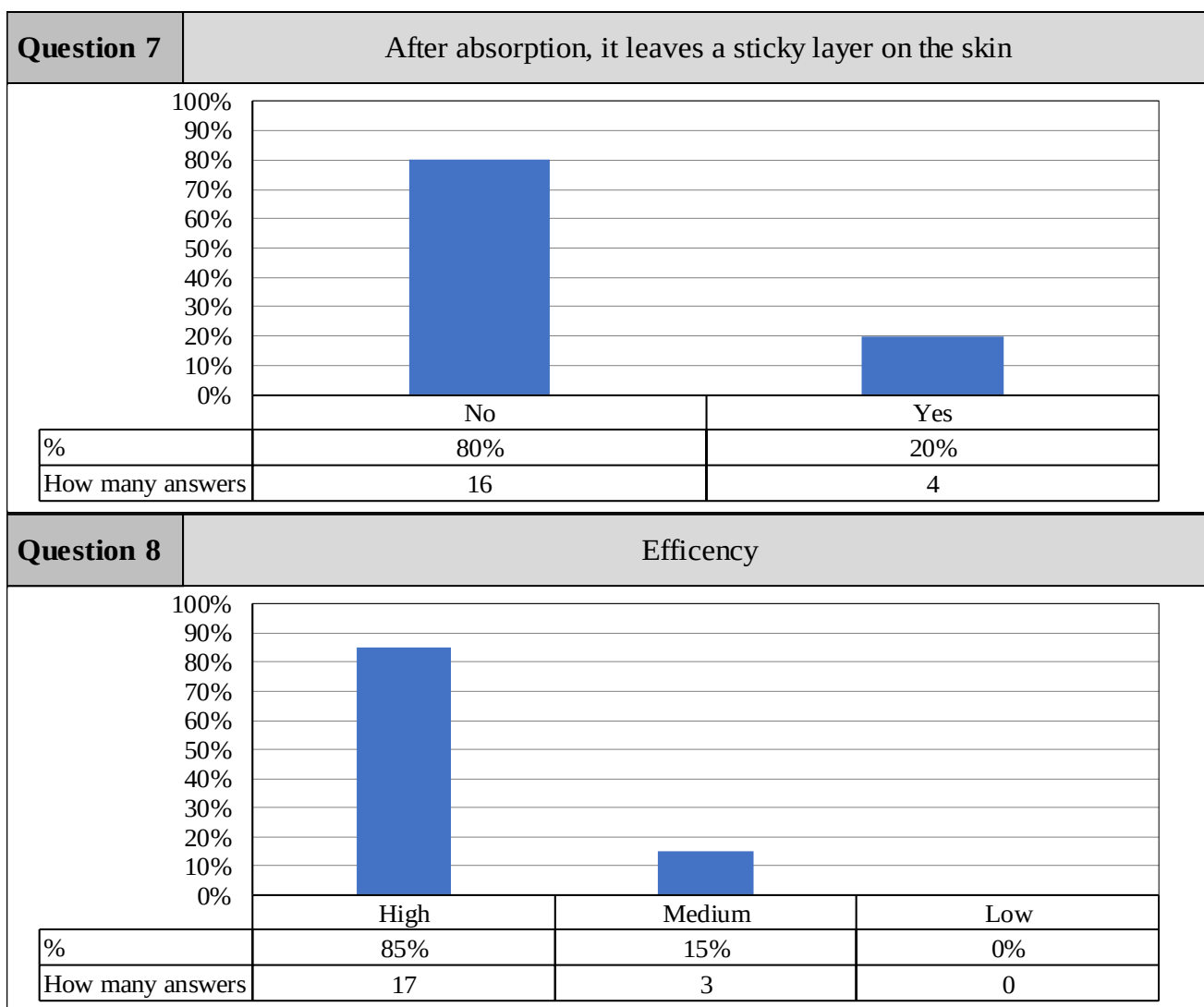

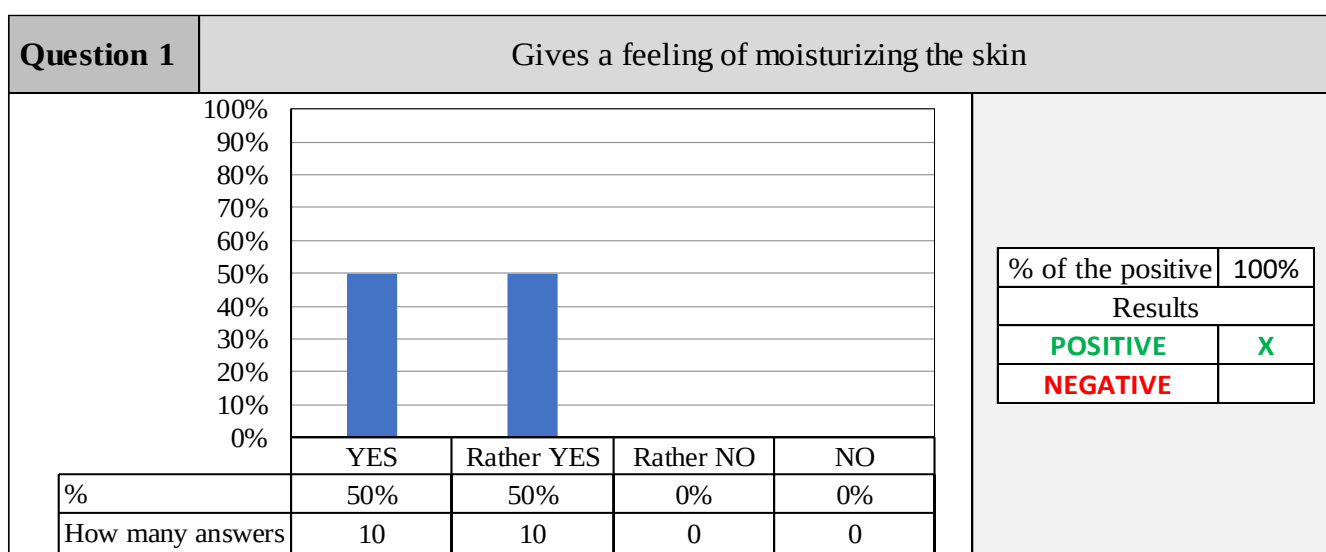
1. Results of organoleptic evaluation

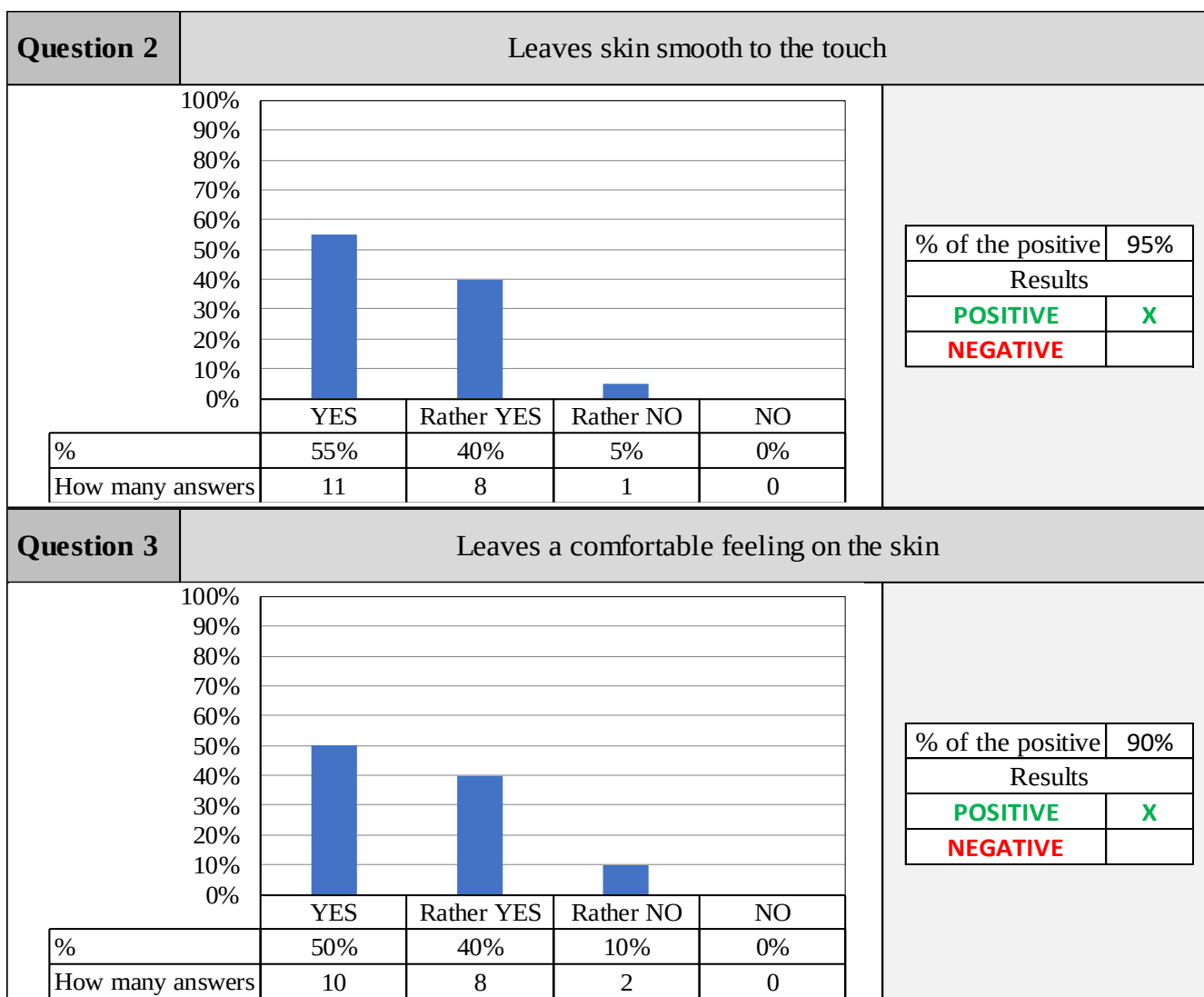




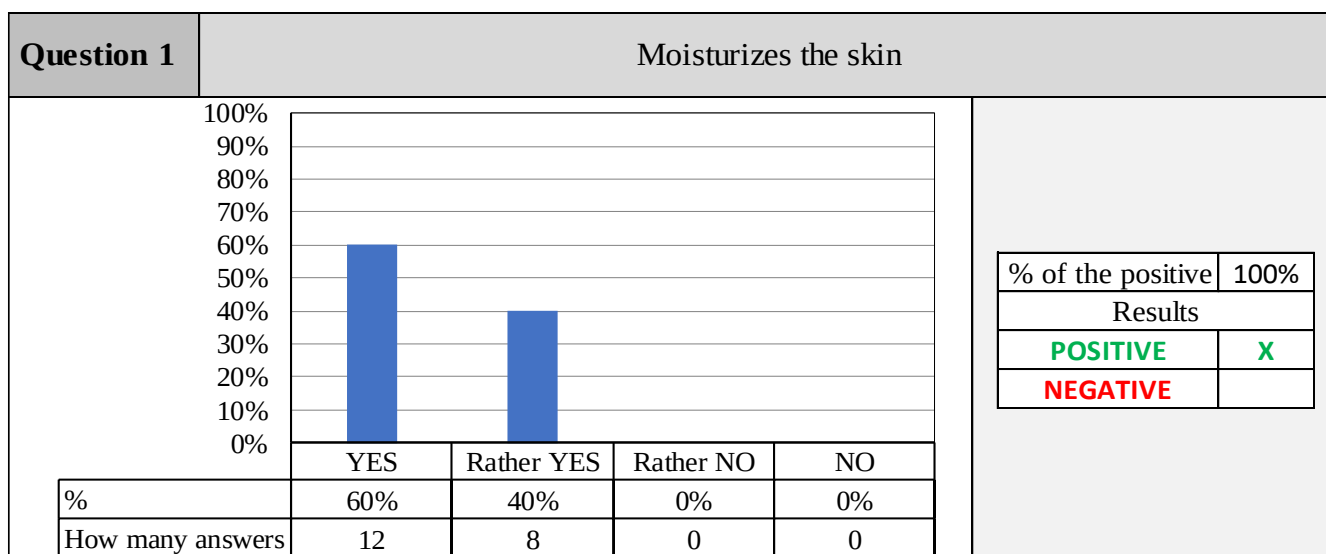


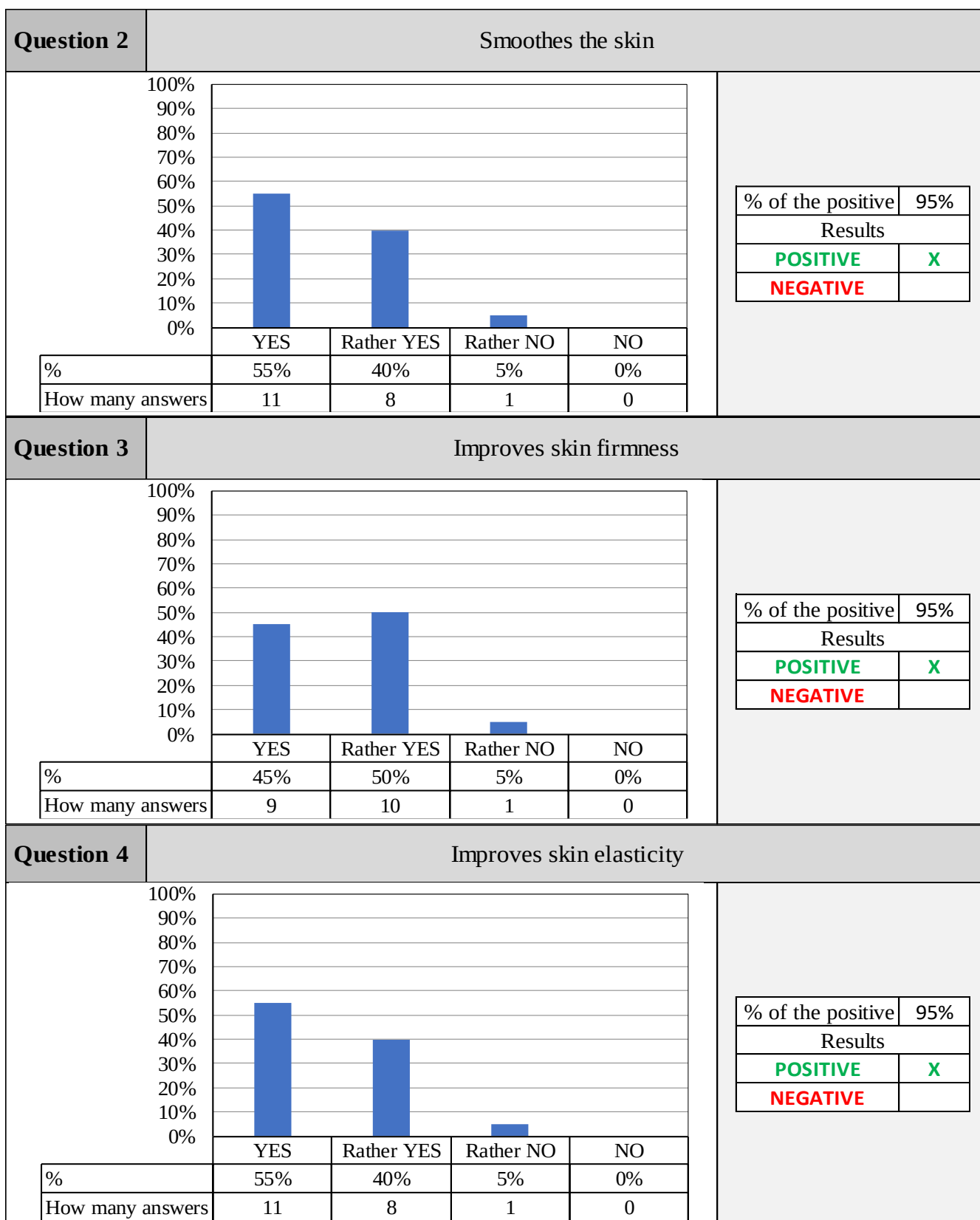
2. EVALUATION OF EFFECTS – Product applied once:





3. EVALUATION OF EFFECTS - Product used regularly (during 4 weeks):

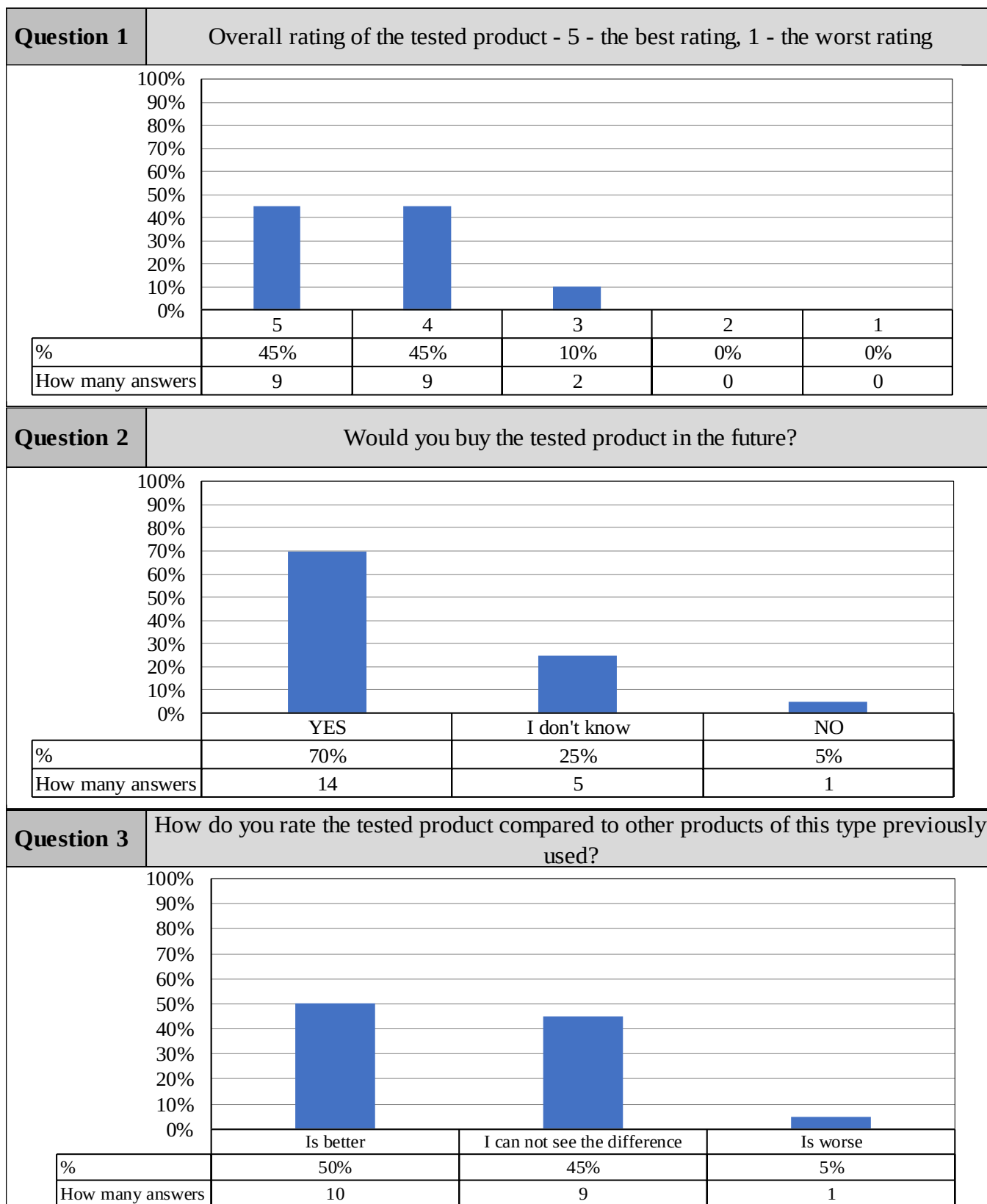

5. DERMATOLOGIST'S OPINION

Based on the conducted research, it was found that in case in 20 of 20 study subjects (all with sensitive skin), the repeated application of the product (within 4 weeks) did not cause any undesirable symptoms, such as redness, swelling, rash on the skin. Moreover, 20 out of 20 study subjects did not reported feeling of discomfort such as itching, burning, tingling.

Based on the conducted research, it was found that when applied as intended, **Even Glow** product is safe for use in the care of facial skin. It is suitable for sensitive skin. The above opinion does not apply to people who are allergic to any of the ingredients of the tested product.

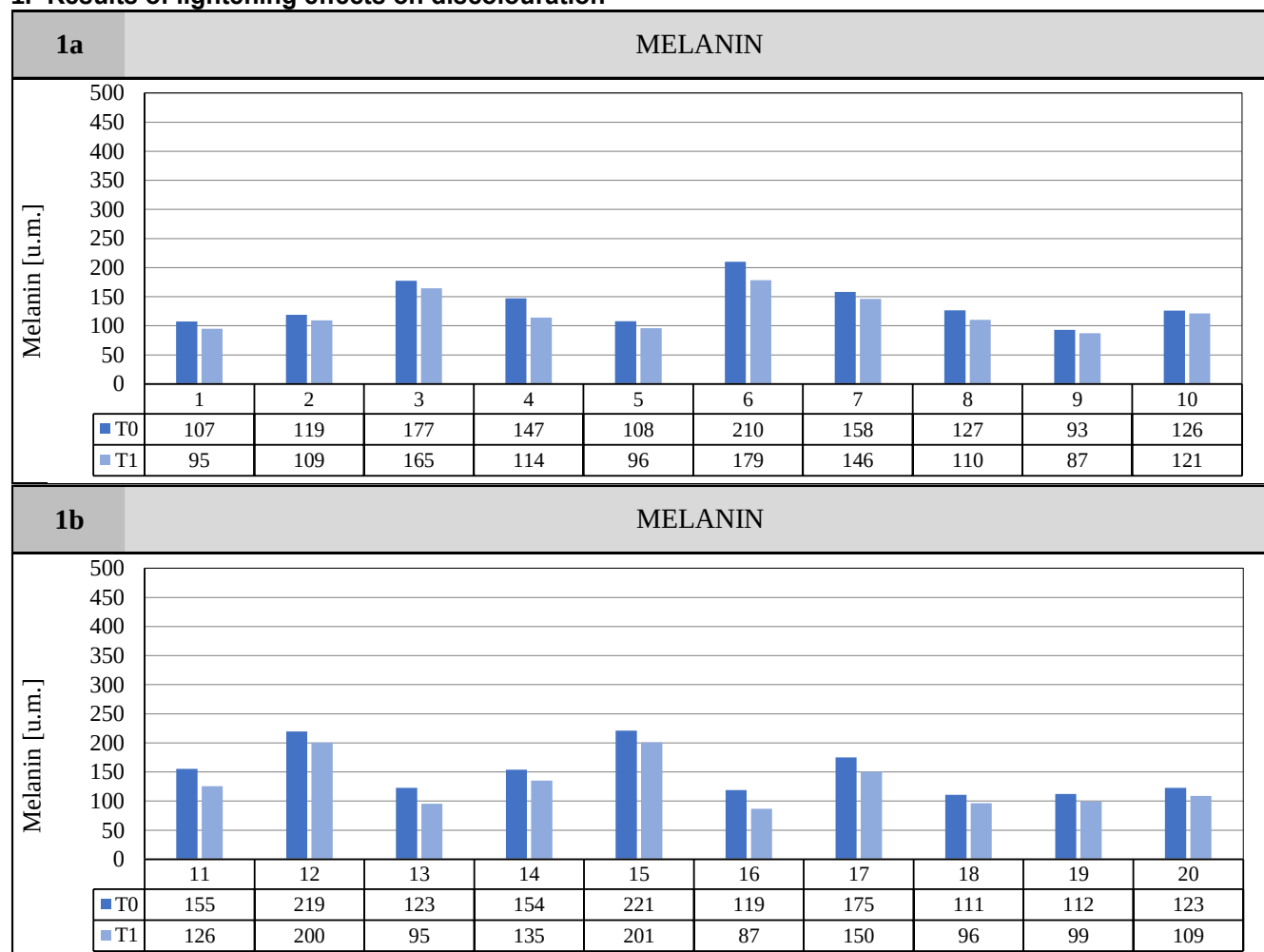
Instrumental test results - the effect of long-term (for 4 weeks) use of the product

The decrease of the parameter in time T_1 is a positive result - it proves the lightening of discolorations.

Images of facial skin fragments in the area of discolorations

The **Visioface® 1000D device** takes photos of facial skin fragments with visible discolorations. The photos taken after regular use of the product (after 4 weeks) show a reduction in discolorations and a positive effect on the skin.

SUMMARY

Based on the conducted in-use test, the following was found about the tested product **Even Glow**:

1. It was well tolerated by the skin in the place of application because in case in 20 of 20 subjects (all with sensitive skin) it did not cause irritation, allergic reactions and any feeling of discomfort.
2. It fulfilled the expectations of the subjects in terms of organoleptic qualities, i.e.:
 - It has the proper consistency;
 - It has a pleasant odour with the proper intensity;
 - It applies and spreads easily;
 - It absorbs quickly and after absorption doesn't leave a sticky layer on the skin;
 - It is efficient.
3. The product once applied, it had a positive effect on the facial skin. Based on the subjective feelings of the subjects, the following Manufacturer's declarations have been confirmed:
 - Gives a feeling of moisturizing the skin;
 - Leaves skin smooth to the touch;
 - Leaves a comfortable feeling on the skin.
4. When used regularly for a period of 4 weeks (in accordance with the directions for use specified by the Manufacturer), it had a positive effect on the skin of the face. Based on the subjective feelings of the subjects, the following Manufacturer's declarations have been confirmed:
 - Moisturizes the skin;
 - Smoothes the skin;
 - Improves skin firmness;
 - Improves skin elasticity;
 - Reduces the appearance of hyperpigmentation/brightens discoloration;
 - Evens skin tone;
 - Improves the overall appearance of the skin.

Based on the conducted instrumental tests, the following was found about the tested product **Even Glow** regularly for 4 weeks:

- evens/unifies the skin color / reduces the visibility of discolorations/ lightens discolorations on the skin by an average of 13% in the group.
- it shows good care properties.

5. Based on the conducted in-use and instrumental tests, it was found that the tested product **Even Glow** can be recommended for use in the care of facial skin. It is suitable for sensitive skin
